PRESIDENT'S REPORT 2019-2020 MARK KNOX QC

We were fortunate to be able to meet in Moncton in September, six (6) months after the Covid19 pandemic began. Following the growth of the 7th Step in Nova Scotia, Newfoundland/Labrador, Ontario, and Saskatchewan, New Brunswick appears to be "the next step" in developing 7th Step across the country. ¹We had to wait until September for our national meeting (we started planting the seeds in February with a trip to Moncton, hosted in space provided by the JHS, for the purposes of a June AGM-delayed due to Covid 19 and concluded that a conventional and virtual "get together" could be done.

With two federal institutions (plus Dorchester Minimum) and another (Springhill) at its border with N.S., New Brunswick was once a thriving 7th step province in earlier days. But without the cultivation of new members-champions from both sides of our unique equation, as well as staff at institutions-all groups are at risk of evaporating. Due to the multiple number of N.B. men and women leaving prisons in the East, we owe it to them to lay the foundation for support and successful reintegration by developing 7th step in New Brunswick.

Congratulations to the continuing great work done by all groups and members, West to East. Here is to recognizing the Pledge, the Seven Steps, and one of our mottos, "Think Realistically."

Executive Director's Report 2019-2020 George Myette

Although our last fiscal year ended on a somber note due to the emergence of Covid 19 and the subsequent shutdown of most activities, we made good progress in many areas and maintained a steady involvement with our various peer support programs and our activity as a member of NAACJ.

As usual, our most significant event for 2019 was our two AGM/Public Forum in Saskatoon, with full attendance from National Board members, Volunteer Facilitators, and key volunteers. The Public Forum was well attended by local community members, academics, CSC staff and 7th Step members. The Saskatoon volunteers did a great job of publicizing the event to promote local interest in 7th Step and community engagement in the criminal justice system. The strategic planning workshops with key volunteers and National board members brought great energy and ideas to the table as always.

Other than new National supported initiatives, I won't dwell on too many specifics in established provinces as those chapters will be giving their own regional annual reports, listing their activities and accomplishments. Starting in the West, our co-volunteer facilitators Alana Newton and Alecia Ozdan made visits to the Mission area to meet with institutional staff at Mission Minimum Institution as well as potential community volunteers/members to start a chapter in the community and in the institution. Staff at Mission were extremely helpful as were several potential volunteers in the community. Alana was able to meet with existing 7th Step members in Mission Institution and they were very encouraged by her visit. We were not able to initiate a group as planned due to the lack of outside committed volunteers and Covid restrictions, but Alecia continues to canvass universities and other resources in the area with a view to resuming our efforts once Covid restrictions are lifted.

In September 2019, Lee Nicholas-Pattillo visited the Tyindenaga First Nation near Belleville, Ontario to facilitate a 7th Step Volunteer Training session and then went on to Milton, Ontario to do the same with groups of community volunteers who are interested to start 7th Step self-help groups in their respective areas. The group in Milton is particularly interested in starting a group in the Vanier Institute for Women, a provincial correctional facility and following up with a community support group as well. These were very productive sessions with good potential for chapter development. We are hopeful that once Covid 19 restrictions are no longer present, we will see additional developments in these areas.

In early January 2020, I was in contact with a CBC reporter in Winnipeg who connected me with a couple of ex-offenders in the community whom she had written an article about in relation to their efforts to turn their lives around. I followed up with these two young men and they expressed an interest to start a 7th Step Chapter there as they felt it would be truly relevant to them and the community. I had planned to travel to Winnipeg to meet with them, but this was pre-empted by the Covid shutdown and will have to wait until a later date. We have been hoping to start a chapter in Winnipeg for many years and will continue to pursue this.

In New Brunswick, Lee began laying the groundwork for future development of 7th Step after receiving expressions of interest from the St. John and Moncton areas. In February 2019, Lee Mark and I travelled to Moncton where we held a small community forum with the help of Louise Leonardi from CFCN and were graciously hosted by the John Howard Society of Moncton. We had a good turnout, including Jodi Heys, a potential board member from PEI and decided that this would be an appropriate location for our 2020 AGM and a larger Public Forum in June.

In Halifax, Peter Brown and Steve Deveaux, senior Halifax members, negotiated a project and some core funding with the Nova Scotia Community College and Provincial Corrections to develop a Peer Support Counselor Training program. Due to limits on the amount of funding, the Board of Directors of 7th Step Canada agreed to supplement the project in the amount of \$3920 for program development and eventual delivery of the program. After initially starting in March, the project has been held up due to Covid 19 restrictions but will resume when appropriate. I continue to give backup support to Dr. Nancy Lewis who lives in Prescott, Ontario and teaches at Potsdam University in upstate New York. Nancy is a dedicated 7th Step member who, along with her students has established a 7th Step group in St. Lawrence County Jail and is working toward establishing a community group in Ogdensburg, New York. Nancy also lends support where she can, in southern Ontario.

Our role as a member of NAACJ has kept us actively involved on a national basis in consultations with CSC and Public Safety on issues such as Pardons, Special Intervention Units in federal prisons, Covid 19 strategies in federal prisons and CRF's, institutional clearances for volunteers and developing health and wellness strategies for federal prisoners. I made 2 trips to Ottawa in the past year to participate in consultations with CSC and Public Safety on these issues and was joined on one occasion by Peter Brown from Halifax. Peter also took my place to represent us at a Substance Abuse conference in Winnipeg in March, hosted by the Canadian Centre for Substance Abuse.

On a personal note, I was awarded the Ed MacIsaac Human Rights in Corrections Award for 2019 and was feted at a reception in Ottawa in November. I absolutely give credit for this award to 7th Step and the many opportunities it has afforded me over the years to be a voice for self-help and peer support. Mark Knox did an amazing job of nominating me for this award and in garnering many letters of support. It was a humbling experience, and I am truly honored.

On a final note, I wish to thank the many volunteers across Canada for all their efforts during the past year and particularly the National Board of Directors for their support and individual efforts in their respective regions. I look forward to another successful year in 2020 - 21.

INDEPENDENT PRACTITIONER'S REVIEW ENGAGEMENT REPORT

As always, things have continued to be interesting and challenging not only in Alberta, but around the world since we last gathered. During these difficult times 'Seventh Steppers' have found the strength and unique ways to come together and provide support and guidance to each other and those in need.

To say the least, agency programs, staff and residents have seen their struggles during times of COVID-19. However, that is not to say we have not experienced positive changes and successes either.

With lots of personnel movements, The Alberta Seventh Step Society has many new faces. Amongst them, we said a heartfelt goodbye to Bob Alexander from his role as Executive Director after 16 years of dedicated service. We wish him the best during his retirement. After six years with the agency, I am delighted to have taken over this position and am passionate to continue and grow the amazing work that Alberta Seventh Step achieves on a daily basis.

Although, our Community Residential Facility has seen a decrease in numbers due to the pandemic, we continue to accept intakes regularly and assist with community reintegration needs of offenders all while working with Alberta Health Services to ensure the health and safety of residents and staff.

With the cease of institutional visits, Core Groups were put on a temporary hiatus in March. We are anxiously awaiting the approval to return to both Bowden and Drumheller for formal meetings once again. In the meantime, our Outreach Team have been hard at work ensuring they can still support our members by mailing out workbook packages regularly and responding to correspondence. In person community groups have started up again, along with our 8-week Taking Responsibility program. Weare excited to announce our new 12-week Taking Responsibility- Domestic/Intimate Partner Violence program is close to completion and are hopeful for future partnerships with Probation and the Courts of Alberta.

Our Public Legal Education Speakers had another successful year speaking to over 16,518 youth, over 319 presentations at over 260 venues and as schools resume, so do our speakers. Although, in a different form, they are back in full-swing ready to present digitally or in person to deliver their story and resources to youth. During these unknown times where our communities, nation and world seems closed, Seventh Step will always remain open. We will never stop working as a team and united front to help those as we have been helped.

British Columbia – Annual Report 2019-2020

March 21, 2020

The past fiscal year in British Columbia showed us maintaining our presence on Vancouver Island with aninstitutional chapter at William Head Minimum Security Federal Institution and a community chapter in Victoria. We have seen a steady stream of successes with our William Head members (mostly lifers), with 7 members receiving parole or day parole during that time. This was the culmination of several years of steady group participation by the members and a tribute to the 7th Step philosophy. Most of themembers remained in the Victoria area and are attending community meetings when they can. Covid 19shut down outside volunteers attending inside meetings and we are hopeful to resume normal group operations in the fall.

One of our Victoria community members, Nathan Gregg, who has a tree planting background, has started a non profit social enterprise (Tree Hab) which will operate in the Prince George area during thesummers and will give preference to 7th Step members and work release inmates who will follow the 7thStep philosophy. The kickoff will be in 2021. Nathan has made arrangements with a local CBRF in PrinceGeorge that will supply accommodation.

Thanks to the efforts of our Western Co-Volunteer Facilitators, Alana Newton and Alecia Ozdan, we had a presence at the Mission Institution Community Resource Fair in the lower BC mainland in the June andNovember and also met with potential community volunteers. Alana was able to meet several previous 7th Step members in the institution along with staff who were supportive of starting a group, before handing things off to Alecia in December who continues to pursue this objective by recruiting local volunteers. Logistics and Covid 19 put things on hold in the last quarter of the fiscal year but Alecia is hopeful of picking things up again with circumstances permit. The primary goal is to establish a solid group of community volunteers who can support an inside group in Mission Minimum Institution.

In the fall of 2019, George was invited to sit on the board of the British Columbia Criminal Justice Association as a representative of 7th Step. The BCJA is a chapter of the Canadian Criminal Justice Association and has a focus on public education, criminal justice best practices and innovation.

St. John's Newfoundland – Annual Report 2019-2020

From 2019 to March 2020 pre Covid19 our volunteer group had 5 devotedvolunteers.

We had program running inside our local prison HMP weekly. We usually had 10weeks to complete a program. We took the first few weeks getting to know the new group of inmates and then we started the 7 Steps. Our community group was unfortunately a hit or miss with those released from prison. We did have at times one to two from the community along with two volunteers meeting in a church hall room at no cost.

Since Covid19 all programs from outside resources have been cancelled inside the prison HMP.

Since Covid19. We have cancelled community group until a month ago. We are still unable to return to the church hall so we chose. Tim's to meet. We had two interested community members but since one dropped out but at time contacts avolunteer the other has since been rearrested.

We have a past 7 Step. Volunteer return to group making our volunteers to six.

We are in the process on arranging a fundraising so we can make copies of ourmanual, make bookmarks etc.

Nova Scotia – Annual Report 2019-2020

7th Step Society of NS Street Group

A primary way in which 7th Step Society of NS members receive and offer support is through weekly support group meetings held in Halifax, NS. In late March 2020, the street group meetings began being held online due to the COVID-19 public health restrictions. To date, 25 weekly online street group meetings have been held and, although it presents challenges especially for people who may require or prefer in-person meeting, it has been successful in continuing to provide a way for members to engage with each other, provide and give support, and manage the adverse effects of social isolation. Members have also organized and participated in gatherings this summer (such as Mark Knox's Canada Day Backyard Barbeque and the Point Pleasant Park Picnic) to help with community-building during the pandemic.

Additionally, discussions stimulated by the Black Lives Matters protests beginning in May 2020 led to the development (coordinated by Doreen Carter) of an Indigenous land acknowledgement and an anti-racism statement that is now read at the beginning of each street group meeting.

Limitless Peer Support Program

The Limitless Peer Support Program is a joint initiative between the NS Department of Justice (DoJ), the Nova Scotia Community College (NSCC), and the 7th Step Society of NS. Limitless is a program, operated by the NSCC and the NS DoJ, that prepares and supports people serving provincial custodial sentences in Nova Scotia to transition to college (NSCC) and acquire a tradeafter their release. The 7th Step Society of NS received funding to hire a core group member with lived experience of incarceration and reintegration to provide peer support to people participating in the Limitless program in the 2019-20 and 2020-21 school years. Steven Deveau was hired into the role and has been supporting Limitless participants – helping them navigate issues and linking them to services and supports – since December 2019. Building upon this work, a partnership was developed with 7th Step National to support the development of peer mentoring training materials – work that is currently underway.

Central Nova Scotia Correctional Centre Reintegration Program

In early 2020, the 7th Step Society of NS partnered with the Correctional Services Division of the NS Department of Justice to develop and conduct a 6-week program in the Central Nova Scotia Correctional Centre (CNSCC) focused on helping people plan and prepare for community reintegration. The program was initiated in early March 2020 and three sessions were delivered the CNSCC by Peter Brown and Steven Deveau. However, in late March 2020, the program was paused indefinitely because of public health restrictions imposed by COVID-19.

7th Step Society of NS Community Outreach

The 7th Step Society of NS continues to create opportunities for its members to share their stories and experiences at various venues, such as schools, in the community. Anne Marie Houston has been leading this initiative since October 2020 and has created supporting materials (e.g., pamphlets, presenter packages). Prior to COVID-19, 7th Step members participated in several speaking events at schools throughout the Halifax region. Additionally,7th Step members attended and spoke at nation events, including Steven Deveau's talk at a national forum hosted by the Mental Health Commission of Canada.

7th Step Society of NS Peer Research Team

In September 2019, funding was received by the Change Lab Action Research Initiative (CLARI) to create a peer research team consisting of members of the 7th Step Society of NS with the goal of developing and conducting a research project on a topic chosen by the team. Since then, a peer research team was formed, a research topic was chosen, a study was designed, research ethics approval was received, peer research training was completed, and a study was initiated. The qualitative study is examining the reintegration needs of formerly incarcerated people who've interacted with the 7th Step Society of NS, with a particular focus on examining their views and experiences with the 7th Step Society. To date, peer researchers (ex-offender members of the 7th Step Society) have conducted research interviews (mostly by Zoom) with 12participants. Up to 20 people will be recruited and interviewed. The study is expected to be completed in early 2021.

7th Step Society of NS Board of Directors

Board members have kept busy with establishing the necessary policies and procedures to manage the range of initiatives with which the 7th Step Society of NS has been involved, as well as the associated challenges. The Society's new human resource and payroll activities has led to obtaining the services of a bookkeeper, filing appropriate paperwork the NS Registry of Joint Stock Companies and the Canada Revenue Agency, and purchasing officer liability and general liability insurance. The Board has considered and discussed issues of diversity and inclusion in relation to the 7th Step Society of NS that will be incorporated into its regular business and decision-making (e.g., representation on the Board).

Ontario - Annual Report 2019 - 2020

Needless to say, the pandemic has taken a toll on face-to-face interaction since last February.

The Peterborough Street Group last met in January 2020 with all members in attendance.

As a high note, Brian (Bucky) was in attendance in his wheelchair, the same replacement powered wheelchair provided for so generously by the national Seventh Step Society in 2019. Bucky continues to be most grateful and continues to be an active and contributing member of this group.

The institutional group that has been planned and prepared for at the Vanier Correctional Centre for Women was to have begun its' sessions in February 2020. This date came about after some delays due to staffing issues at the institution. Through a re-doubling of efforts with provincial corporate correctional management, the program was re-approved and targeted for 2020 commencement.

Given the pandemic, all volunteers and associated programming were put on hold. In the interim, and pending a return of volunteers, Donna Keating is maintaining the relationship with the institution. Donna also continues to meet with Kim O'Connell and Cathy Morris as the trio heading up this initiative. A telephone meeting is scheduled with the institution in September to review status/progress. As a final note, the three individuals referred to above are also supported by an additional four volunteers.

Hopefully, late 2020 or early 2021 will result in some significant forward movement in our programs.

And, then, like everywhere else in the world, the COVID-19 pandemic struck, and in-person meetings were shut down. In the past six months or so, we have continued to maintain contact with our members through our Facebook page, Zoom meetings, including the very successful Halifax 7th Step Zoom meetings and, in late August, an in-person meeting that started outdoors and moved to a local coffee shop. Lucky to be Islanders at this time!

OVERVIEW

The PEI 7th Step Society was started in or about 2007 by Rev. Scott MacIsaac, then chaplain of the Provincial Correctional Centre. For a few years, he held meetings in the jail and in the community. Over the years, the members have attempted to hold street meetings in Summerside as well as Charlottetown. As members changed, the group waned.

In 2018, the group was re-energized by a donation from the Prince County PEI chapter of 100 Women Who Care. This group was very enthusiastic about the concept of 7th Step Society – in PEI and in the rest of Canada – and felt it worth their support.
