Annual Executive Director's Report

March 31, 2023

The fiscal year 2022-23 was a pivotal one for 7<sup>th</sup> Step Canada as we entered a new phase of development in our mission to prevent recidivism. Thanks to the continued support of Public Safety Canada through the NVO Grant Program, we created a full-time position for Pete Brown – National Program Manager, who will be responsible for the continued development of volunteers and peer support programs across Canada. This is the first full time staff position in the history of 7<sup>th</sup> Step Canada and were able to implement the 4 year "Pardon Me" pardons support project, in partnership with the Alberta 7<sup>th</sup> Step Society. The project is headquartered in Dartmouth, Nova Scotia, with a regional office in Calgary, Alberta. This program will provide free services to individuals wishing to obtain a Pardon or Record Suspension from the Parole Board of Canada.

In October 2022, we held our first in-person AGM and Public Forum in 3 years in Charlottetown, PEI with good attendance by National Board members, 7<sup>th</sup> Step members from the Maritimes and members of the public from Charlottetown. We had some wonderful presentations by persons with lived experience during our Public Forum and hope to use this as a springboard to engage the community in our efforts in PEI.

In September 2022, Pete Brown, Steve Deveau and I presented a workshop on Peer Support and Self Help at the CCJA International Congress on Probation and Parole in Ottawa. This was a great opportunity to network and share our knowledge with people from around the world as well as gain valuable insights from the efforts of criminal justice programs in other countries.

Throughout 2022-23, I continued in my role as a board member of NAACJ, representing 7<sup>th</sup> Step and the voice of lived experience. Along with Pete Brown, I participated in consultations with Public Safety Canada and CSC as we pursued the initiatives outlined in the Federal Framework to Reduce Recidivism.

Our forecast for the year ahead is very positive as we plan for continued volunteer and chapter development in British Columbia, Ontario, Quebec and New Brunswick through Public Forums and community engagement. Volunteers are the mainstay of our efforts as we continue to focus on peer support programs and fulfil our mission as a self help organization. The efforts of our board members, core group members and various stakeholders make this all possible and I thank you for these contributions.

Hello 7<sup>th</sup> Step Society of Canada

Moving from part time program co-ordinator to full time program manager with 7<sup>th</sup> Step Society of Canada has been an amazing journey and I want to thank each and everyone of you for the opportunity.

The growth of this organization continues to amaze me with multiple provinces expanding rapidly. There has been significant growth in British Columbia, Alberta, Ontario, Quebec, New Brunswick, and Nova Scotia with Newfoundland, Prince Edward Island, and Saskatchewan holding the line.

Volunteers have been recruited in Abbotsford BC with the 'Taking Responsibility' (TR) program starting in the Fraser Valley Women's and Mission Minimum prisons in September. (With a Core Street Group in the works).

Milhaven Maximum in Kingston Ontario is still hosting the Queen's Student Volunteers for the TR program in the SIU.

Ottawa is on the cusp of starting a Core Street Group and facilitating the TR program in a transition house for men returning to the community from Ontario Provincial jails that is run by our Core Group Member Spencer Kell.

Montreal has been a hot spot for conversation about 7<sup>th</sup> Step and with our upcoming AGM and a public forum being held there, we are hoping to have a Core Street Group starting and TR being facilitated in prisons over the next few months.

New Brunswick has started the TR program and been very successful in the provincial women's jail under our very own Tammy MacDermaid's persistence. This has been another first for 7<sup>th</sup>

Step with staff facilitating the program and having a peer facilitator (Nancy Everson) join in the groups through Zoom. There have been several meetings with Corrections Management in the past year and we can expect 7<sup>th</sup> Step to grow in New Brunswick over the coming months.

On to the 'Pardon Me, 7<sup>th</sup> Step' program. With the \$1.1 million in funding secured late last year over a 3 ½ year commitment, Pardon Me has been very successful as a program within 7<sup>th</sup> Step. We have 6 employees within this program, 2 in Alberta and 4 in Nova Scotia. We have had well over 100 clients with a couple of successful Record Suspensions, and more being submitted to the Parole Board regularly. If they did not know who 7<sup>th</sup> Step was before, they sure do now! The program is running smoothly with only minor adjustments thus far. Cindy Brian (manager) and her team of case managers have made my job very easy when it comes to this program.

On a final note of business, we have secured \$500,000.00 in funding/donation from North Pine Foundation which will change 7<sup>th</sup> Step Society of Canada over the next 2 years in how we connect with our community across the country.

A very exciting time in 7<sup>th</sup> Step and I look forward to being a part of its growth and prosperity in the year to come.

### Treasurer's Report 2022-2023

Currently we are in a positive financial standing with a budget that is well controlled and managed. This is reflected in our Operating Budget vs Actuals Statement and our Year End Statement. Our annual financial position has been reviewed and verified by Cremers & Elliott Chartered Accountants

This was our first full year returning to a normal financial environment since the Covid-19 pandemic. As we had a few years where we could not carry out normal financial operations, we still have a surplus of funds. Our primary stakeholder, Public Safety Canada has authorized us to use these funds to help expand our operations in the coming fiscal year.

In this past fiscal year, we had sufficient funds to carry out our regular activities as well as use the surplus to create a National Program Manager position. Here are some examples of our expenses:

- Full in person AGM held in PEI October 21/22, 2022.
- Bilingual translation of program material
- Volunteer development
- Support for the "Taking Responsibility Program" in Ontario and New Brunswick
- National Program Manager salary and benefits

Going forward, a large portion of our overall budget is the 4-year Public Safety Contributions Grant for the funding for the Pardon Me Project which was received In 2022. This money is separate from our regular operating budget and is administered by the Pardon Me Program staff in conjunction with National 7th Step and a partnership with The Alberta 7th Step Society.

For our next fiscal year, we have budgeted for our normal operations as well as the cost of our new National Program Manager. We are looking for extra funding to cover future cost of this position, as well as develop new projects for 7th Step. So far, we have applied to Red Cross Vulnerable Sector Fund and North Pine Foundation for funding to help with these goals. If we are unable to secure another source of funding, we will revise our budget to cover costs accordingly.

This has been a very positive year financially, seeing us move forward and expanding our scope. I feel confident that we will find the extra funds needed to continue our expanded operations and continue to grow.

#### INDEPENDENT PRACTITIONER'S REVIEW ENGAGEMENT REPORT

#### To the Members of The Seventh Step Society of Canada

### British Columbia – Annual Report

The 7<sup>th</sup> Step Society of Canada – British Columbia Chapter

British Columbia activities remained relatively stagnant during most of 2022-23, with the exception of regular Core group meetings via Zoom based out of Victoria and hosted by our anchor volunteer member, Jack Yu.

Late in the fiscal year, we saw a strong interest starting to develop in the Fraser Valley with requests from several federal institutions to have us begin delivering our Taking Responsibility (TR) Program. George Myette followed up with Fraser Valley Women's Institution, Matsqui Institution and Mission Institution along with the Fraser Valley University to begin developing volunteer resources in the area to deliver the TR program. In late March, George and Pete Brown – National Program Manager travelled to Abbotsford to host a Public Forum which was attended by CSC referred volunteers and various members of the community, including formerly incarcerated persons, with a focus on 7<sup>th</sup> Step peer support programs and the opportunity to become involved in the area. The turnout and interest were very encouraging and laid the groundwork for further development in the coming year. Of primary importance will also be the development of a community support group for 7<sup>th</sup> Step members and this will be a concurrent focus along with institutional programs.

# New Brunswick - Annual Report

The past year has seen some big developments with respect to 7<sup>th</sup> Step's presence in our province. A great deal of this is thanks to the tireless work of Tammy MacDermaid, who joined the 7<sup>th</sup> Step National Board in January 2023 and has been instrumental in raising the profile of 7<sup>th</sup> Step in New Brunswick. I am proud to report that we have achieved last year's goal of getting 7<sup>th</sup> Step into the New Brunswick Women's Correctional Centre in Miramichi. Tammy MacDermaid, Nancy Everson and I facilitated our first round of the Taking Responsibility program starting in January. Learning from that experience, Tammy revised the TR program to incorporate a continuous intake model better suited to the needs of the population at NBWCC; we launched a second round of the program using this model in March.

In the community, our New Brunswick Zoom meetings continue to be well-attended and we continue to benefit from the support of dedicated volunteers both in New Brunswick and across Canada. Looking ahead, our goal is to build sustainably on the foundation we have laid, both by expanding to other correctional centers in the province and by establishing our first inperson street groups in the community. We have big goals for 7<sup>th</sup> Step in New Brunswick – our biggest hurdle at this point is finding the manpower to execute our plans, but we are hopeful that as we continue to expand, we will see an increase in local volunteers who are able to help out on the ground. There are so many New Brunswickers who can benefit from 7<sup>th</sup> Step and we are excited about helping to make that happen!

### St. John's Newfoundland – Annual Report

### 2023

**St John's** - This past year has had it struggles with our program as we have had no access for 8 months inside HMP due to lack of staff, holidays and sick leave. Before this we had been consistent over the past 9 yrs. We are finally back inside to commence our TR program the past month, starting in September.

We have two new volunteers waiting to join us, but we are waiting on their criminal record checks to be completed and the return of consistency in entering HMP. We lost one volunteer this year as she relocated to another province.

We had one fundraiser this past year and used what we raised from a basket filled with donated items valued just under \$500.00 to pay a few bills i.e., our web site and purchased 7 Step long sleeved T Shirts. We also had three community information booths with a fair bit of interest in what 7 Step is all about and also reaching out to other people involved in our community who also work with those who fell between the cracks.

Adrienne Peters, Criminologist, who is one of our volunteers, gave a presentation to Legal Aid and spoke on the NL 7th Step program.

There is a working group in St. John's with the Justice Minister and several people from Justice, where Adrienne also participates. Again, 7th Step is discussed there and they are working on a manual for the inmates at HMP.

We applied for and received a grant for \$1600. We have used that money to hire a university student to collect information on art-based programs inside the prisons that are successful. Adrienne, who also teaches at Memorial University has had meetings with Zina Lee who is Head of Criminology in Fraser Valley University, BC. Zina is looking at models like the approach NL uses and hopefully pass on to her students. Adrienne will be following up with Zina. **Donna Gardiner – St. John's Facilitator & Director** 

**7 Step Whitbourne** - The Youth group in Whitbourne NLYC had ceased due to low population. We have a new staff member / volunteer who wants to start offering the TR "Taking Responsibility Program" as well as starting a core group inside the institution as residents increase. We have the possibility of restarting a youth group at the provincial institution.

### Nova Scotia – Annual Report

April 1, 2022 - March 31, 2023

This year has been hectic! There is a steady stream of new core group members at our street group meetings. Our Peer Support team has had a few challenges, but we face them together and learn from them. We have a presence at the Provincial Court and on the streets to reassure individuals that we care and can provide support.

The Taking Responsibility Program has taken on many forms and is proving to be a valuable program. From facilitating at Jamieson, it has now transformed into a revolving program. Having a Peer Support Worker assisting with the TR Program at the New Brunswick Women's Correctional Centre / NB Youth Centre (Miramichi, NB) is a huge accomplishment. We have been working hard to have 7th Step facilitate programs in Correctional Facilities in Nova Scotia. Peer Support Workers instill hope in incarcerated individuals. It is gratifying for everyone involved. I can't think of a better way to become a productive member of society than to share lived experiences with others going through the Criminal Justice System.

COVID played a considerable part in the lack of programs by individuals with lived experience going inside. We are still not in Federal Prisons in person, but have been working hard to accomplish this. Some of our core group members have been persevering to have 7th Step go into the Waterville Youth Center. Our other programs, such as the Peer Support Training, have been facilitated via Zoom, which has challenges. It's different from in-person, but we make it work.

Our 7th Step t-shirts have been well received! A core group member designed the logos. We have Peer Support t-shirts and a 10th Anniversary/Prisoners' Justice Day t-shirt available. The Peer Support Workers also received jackets with the Peer Support logo. We wear our t-shirts in the community when doing OUTREACH and facilitating PROGRAMS. We have also updated our pamphlet, flyer and bookmarks!

7th Step Canada introduced a new program, Pardon Me 7th Step. This program assists individuals in obtaining Pardons/Record Suspensions. We opened an office in Dartmouth managed by ex-offenders! We have a Program Manager and three Case Workers. It is

rewarding to help others move on from the wreckage of the past towards a brighter future. It proves that we are not our crimes and that people can change.

The Volunteer Coordinator at Quinte Detention Centre will be reaching out to the Volunteer Coordinator at Vanier (provincial) to promote the TR booklet by correspondence at their facility.

## Prince Edward Island - Annual Report

### INTRODUCTION

The Prince Edward Island 7<sup>th</sup> Step Society is like a cat: it has had a number of lives. And with a number of wonderful folks in leadership roles and as active members. In this iteration, 7th Step has been active in PEI since 2018. In the past year, we have been able to continue our practice of the past couple of years of Zoom meetings, and hybrid meetings when we are able to do so.

As members changed, the group waned.

In 2018, the group was re-energized by a donation from the Prince County PEI chapter of 100 Women Who Care. This group was very enthusiastic about the concept of 7<sup>th</sup> Step Society – in PEI and in the rest of Canada – and felt it worth their support.

As a result of this donation, new members were sought, the experience and skillset of the group in Halifax was enlisted, and the PEI group began anew. A provincial executive was struck and new members began to show up for meetings.

The PEI society became a formal entity, again thanks to our friends in Nova Scotia, in 2019 when we were incorporated.

### 2022-2023 ACTIVITIES

The following items represent a number of the activities that have taken place for 7<sup>th</sup> Step PEI during the past year:

• The most exciting development that occurred in 2022-2023 was in October when PEI hosted the 7th Step Society of Canada 2022 annual general meeting and public forum.

- What is best about this past year is the consistent support and dedication to 7th Step nationally and to the PEI society from members within PEI and throughout Canada. It really shows the great privilege it is to count such amazing people in the country as fellow 7th Step members and friends.
- Although the COVID-19 pandemic has brought much difficulty to our work to advance 7<sup>th</sup> Step Society, the introduction of Zoom meetings has permitted 7th Step on PEI to form connections with 7th Step members throughout the country in a way never possible before. For a place as small as PEI, this has been the difference between an active group and a non-functioning one.
- We were also able to get an idea of how other provinces were managing to maintain and grow their groups - and in the case of New Brunswick develop a brand new group and begin to hold the Taking Responsibility program in a provincial institution. We are grateful for this upside of the pandemic, because this brought new perspectives and contacts to our members.
- Like all groups, the PEI society has seen its highs and lows in the last year: we have lost members who were cornerstones to the success of the group; and we have gained new members who are new cornerstones. We have learned a great deal about what it means to be in community, bringing various views and histories and beliefs together and, in the middle of all of this, learning trust and ensuring respect.
